SERVICES PROVIDED TO SURVIVORS OF CRIMINAL ACTS

In accordance with the Act to Prevent and Fight Sexual Violence in Higher Education Institutions (CQLR, c. P-22.1), Marianopolis College adopted a Sexual Violence Policy, which aims to:

- protect the right to a safe and respectful learning and working environment for each member of the Marianopolis community;
- prevent sexual violence and build awareness in the College community about its nature and effects;
- promote timely and coordinated responses to disclosures and reports of sexual violence, including support resources for complainants;
- provide a complaints processing mechanism that defines the roles and procedures to address allegations of sexual violence.

The College provides the following services to its students and employees who are complainants of sexual violence or sexual offences under the Criminal Code of Canada:

- psychosocial support and counselling;
- academic and non-academic accommodations;
- referrals to resources inside or outside the College;
- measures to protect them from reprisals;
- information about their rights and options.

COMMITMENT

Marianopolis is committed to fostering an environment where all members of its community feel respected, safe and free from sexual violence. Through the Sexual Violence Policy, the College affirms a zero-tolerance stance on sexual violence. The College recognizes the critical

importance of proactive, accessible and effective approaches that prohibit, prevent and respond to sexual violence.

COMPLAINTS PROCEDURE

In accordance with the Act to Support Persons who are Victims of Criminal Offences and to Promote their Recovery (CQLR, c. P-9.2.1), Marianopolis students or employees who are complainants of sexual violence can submit a written complaint if they are dissatisfied after receiving the services described above.

The written complaint must be submitted by email to the address below within twenty (20) opening days and must include the complainant's full name, contact information, and a detailed explanation as to why they are dissatisfied with the services they received.

The complainant will receive a written response informing them of the outcome of their complaint within forty (40) opening days.
